Sub: Final Date for taking Transfer Certificate (TC) from the allotted institution.

## Sir / Madam,

In inviting a reference to the subject cited above, I am directed to inform you that as per this Directorate letter No. 1975 dated 08.04.2021, the SPOT selection and admission has already been completed on 10.04.2021 against the available vacant seats (Category wise and Subject wise). But, this has come to the notice of this Directorate that, some candidates have taken TC after the SPOT Admission for which the institutions are requesting SAMS and TE & SCERT to update the admission status in concerned institutional login. In this context, it is communicated that the updation of admission status is not feasible if the provision for issuing Transfer Certificate (TC) is continued frequently.

It is therefore requested that a Common Notice may be published in the institution notice board for general information of the candidates that, **no Transfer Certificate (TC) will be issued after 19.04.2021.** Hence, the students who want to take TC from any institution, in which they are continuing at present, are eligible to apply for their transfer and issue of the same by

19.04.2021 itself. After this dateline i.e. 19.04.2021, the institutions are not allowed to issue any Transfer Certificate (TC).

The vacancies which will be created after the issue of Transfer Certificate (TC) by 19.04.2021, can be filled up against the particular social categories / subject categories vacant seats, out of the empanneled list already available in the institution, on the basis of the reporting made by the applicants on the date of SPOT admission i.e. on 10.04.2021 as per the guideline. **The vacancies available against the ST and SC categories can not be filled up by any other category students**. The institution can admit the students against the available vacancies latest by 22.04.2021 and update the admission status accordingly in concerned institutional login for information of the SAMS and SCERT.

This may be treated as most urgent.
